- Able to attend all the synchronous e-learning sessions. Participants will require an internet-enabled device with Zoom installed, webcam, microphone and audio.
- Nominated by their respective Governments.
- Proficient in written and spoken English.

Objective

- This course will equip participants with knowledge on addressing issues on environmental conservation, coastal population, and urbanisation.
