- Mid to senior-level government officers (BS-17 and above) nominated by respective Federal/Provincial Department.
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with a functioning webcam, microphone and audio;
- Nominated by their respective Governments;
- Proficient in written and spoken English, and
- In good health

Objective

- To help participants understand stigma and discrimination issues and their impacts on healthcare services and ending AIDS program.
- To guide participants on how to develop and integrate stigma and discrimination reduction programs into their national or sub-national HIV programs.
- To ensure that stigma and discrimination reduction strategies are possible, feasible, and measurable.
- To initiate networking among stigma and discrimination program manager from various countries for knowledge, experience and technology transfer to maximize S&D reduction in health facility implementation.
