## **B)** General Conditions:

- 1. Must have a valid proof of foreign nationality (self and parent) i.e. copy of passport.
- 2. Must have a valid proof of Pak-Origin in the form of Pakistan Origin card/NADRA I.D. Card or Pakistani Passport.
- 3. Must have studied and passed 12<sup>th</sup> grade or equivalent exam **physically** from abroad.
- 3. Updated/latest application form which can be downloaded from EAD's website <a href="www.ead.gov.pk">www.ead.gov.pk</a>., should preferably be typed & printed and submitted in <a href="quadruplicate">quadruplicate</a>, along with attested copies of the following documents: -
  - 1. HSSC or equivalent certificate along with detailed marks certificate/transcripts.
  - 2. Equivalence certificate issued by Inter Board Committee of Chairmen, in case of foreign qualification.
  - 3. Proof of Foreign Nationality, Self and Parent (foreign passport). Green card is not accepted as proof of foreign nationality.
  - 4. Proof of Pak-Origin (Pakistani Passport, I.D. Card etc.)
  - 5. Result Card MCAT.
  - 6. Valid TOEFL/IELTS score card for admission in B.Sc. Engineering/MBBS/BDS in case medium of instruction is not English.
- 4. Candidates interested to apply against the above seats must submit their complete applications on the prescribed application form (in quadruplicate) in R&I/PTAP Section of Economic Affairs Division along with attachments listed above, not later than August 09, 2022 for D. Pharmacy & B. Sc. Engineering and September 15, 2022 for MBBS & BDS. Applications received after the cutoff dates will not be entertained.

# PAKISTAN MEDICAL COMMISSION SANSONS

Pakistan Medical Commission (PMC) invites all medical and dental college aspirants to register for National Medical & Dental College Admission Test (MDCAT) 2022. The MDACT 2022 will be a computer-based MCQ test that will be conducted at designated centers across Pakistan and various international centers

The MDCAT curriculum as approved by National Medical & Dental Academic Board is available online at pmc.gov.pk/Syllabus

To attain admission in private or public medical and dental colleges in Pakistan, an applicant is required to qualify the MDCAT.

The timeline for MDCAT registration is as follows

Normal registration Late registration (With Late Fee)

25th May - 5th July 2022 6th July - 15th July 2022



Any student ABOVE THE AGE OF 16 (On the last date of registration i.e. 15th July 2022), shall be eligible to register for and attempt the MDCAT examination. An FSC/HSSC/A level result/degree IS NOT required for MDCAT 2022 registration. A student can take the MDCAT even before taking their FSC/HSSC/A level exam.

Create an account by providing your basic information, verify your email address & mobile number (mobile number verification applicable for local students only)

STEP

Fill in the form with the necessary personal information, and educational detail and select a preferred exam center. (It is mandatory to input your personal details accurately as per your CNIC/B-Form or Passport etc.)

STEP 4

After profile update, pay the exam fee. It can be paid by MCB Bank Challan, Credit/Debit card (VISA/Master), or JAZZ CASH (Wallet)

STEP

Log onto the PMC Exams account from 20th July to 25th July 2022 to schedule your exam. Scheduling of the Exam shall be based on First Come - First Serve basis, determined from the date of clearance of fee
