
Course Objective:

Government officials will acquire necessary knowledge and ideas to introduce Intelligent Transport System to avoid traffic congestion in respective countries.

Eligibility Criteria:-

The applicants should:-

- Be a graduate or have an equivalent educational background (Engineering or Science)
 - Be a government officials who is involved in surface road transportation related work and in charge of introducing ITS to the sector
 - Have at least 5 years working experience in the field of surface road transportation
 - Proficient in spoken and written English
 - Be between the age of thirty (30) and fifty (50) years
 - Be in good health, both physically and mentally, to participate in the program in Japan. Pregnant applicants are not recommended to apply due to the potential risk of health
