2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria

- Permanent Government Officers (BS-17 and above) only and nominated by respective Federal Government or Provincial Department.
- Mid to Senior-level officials involved in policymaking for sustainability and environmental excellence;
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with Zoom installed, webcam, microphone and audio;
- Nominated by their respective Government;
- Proficient in written and spoken English; and
- In good health and medically fit to attend the course

Objective


- This course aims to provide insights to Singapore’s multi-agency collaboration in formulating and implementing nature-based solutions (NBS) and closing the waste loop to enhance urban resilience. It will also address issues related to urbanization in the context of evolving challenges brought about by climate change.
