- Contract Employees are not eligible

- 3. Nominations of suitable candidates fulfilling the eligibility criteriaduly approved by the competent authority shall be forwarded to this Ministry by 1st August, 2/23 positively. Following points must be considered while nominating the candidates:
 - a. Most relevant candidates should be nominated for the sulect training programmes.
 - b. Nomination of candidates should reach MoEA before the deadline. Late arrival of nomination after the EADs' deadlinewill not be entertained.
 - c. Nomination papers complete in all respect may be forwarded to MoEA through proper channel i.e. through their respective Administrative Ministry / Division/ P&D Department.

(2) Overview of China's agricultural situation: the history of Chinese agricultural development, major policies, basic conditions, challenges, and future development

(3) General introduction of crop production and food security: introduce the concept, meaning, research results and application fields of crop production and food security

(4) China's basic policy and system to guarantee food security: China's agricultural policy, land system, fundamental national policy, high standard farmland system, and grain storage system, etc.

(5) Food loss analysis and solutions: causes and solutions for food loss during harvesting, shipment, storage, consumption and other processes

(6) Cultivation techniques of wheat/rice/corn/vegetable/fruit: select crops according to the national realities of participants, and comprehensively introduce relevant cultivation management techniques

(7) Causes and control techniques of weeds/army worm: introduce the causes and development laws of several specific diseases and pests and the corresponding prevention and control methods

(8) Breeding system of wheat/rice: introduce China breeding system of wheat and rice, and emphasize the importance of high-quality seeds to high grain yield

(9) Mechanized cultivation of corn: introduce common corn harvesting machinery, and demonstrate the significance of mechanization in increasing food production

(10) Introduction of China's extension system of agricultural techniques: introduce China's extension system of agricultural techniques introduce China's extension system of agricultural techniques for tropical crops such as cassava and sugarcane, and corresponding pest control measures.

(12) Field visit: visit China's historical sites and grain storage facilities, and conduct field trips, etc.
