Program Objective

PEPP is to provide 24 months training and the necessary skills for the conception, design, and implementation of development policies. Focus is on international Development with a trans-disciplinary approach to the economic and social problems of developing and transition countries.

Eligibility Criteria:-

The applicant should:

- i. Not hold dual nationality of any developing country
- ii. Hold a bachelor's degree or its equivalent with superior academic achievement earned more than three years before scholarship deadlines January 22, 2023
- iii. Be employed in a paid and fulltime position at the time of the scholarship application deadline unless the applicant from a country identified in the Worlds Bank's "Harmonized list of fragile situations
- iv. Not be an Executive Director his alternate or staff of any type of appointment of the World Bank Group or a close relative of the aforementioned by blood or adoption
