- ii. Less than thirty-five (35) years old in principle (As of April 1st 2023)
- iii. Have a Bachelor's Degree.
- iv. Proficient in spoken and written English, TOEFL or IELTS is required for applicants
- v. Applicants must not be receiving nor planning to receive another scholarship during the program.
