- (Position) Be a government employee in a Mid-level position in the renewable
- (Language capability) Sufficient proficiency in written and spoken English to actively
- participate in the training and write a PCP;
- (Full-time Participation) Be able to attend the KOICA Fellowship Program full-time.
- (Relevant work experience) Have more than 5 years of work experience in the
- renewable power sector;
- (ICT Environment) Have easy access to internet and be able to navigate online for the training
- Be able to contribute to cooperation between KOICA, K-water and participating organizations;
- 8 or more female participants
