- Fully vaccinated with WHO EUL COVID-19 vaccines; and
- In good health.

**Objective**

- The programme will share Singapore’s comprehensive drug control strategy and provide a conducive learning and sharing platform for mid-to senior level official involved in law enforcement (with a focus on drugs) to exchange and share best practices.


