The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria

- Permanent Officers (BS-17 and above) nominated by respective Federal/ Provincial Government.
- Mid to senior level government official involved in disaster risk reduction policy making and/or national emergency planning and management and can include officials from planning and finance/budget or health office.
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with zoom installed and an internet-enabled device with functioning webcam, microphone and audio.
- Nominated by their respective Government
- Proficient in both written and spoken English
- In Good Health.

Objective

• This short online course examines key principles of DRR and the hard coding of resilience into policy, infrastructure and human behavior. Drawing lessons from the COVID-19 global pandemic that demonstration the 'new normal' of interconnected risk, Participants will learn about the Sendai Framework for DRR 2015-2030, 2030 Agenda for Sustainable Development and the Paris Agreement, and possible applications to their State's existing plans. The course will also cover Singapore's experiences in disaster risk reduction and the government's approach in formulating adaptation measures and building resilience in the community. UNDRR will provide globally accepted tools and help the participants become familiar with the tools, use them and develop draft action plans for integrating DRR and climate change adaptation into de4velopment policies. UNDRR will also bring global best practices and encourage sharing of experiences amongst the participants.
