SUBJECT: MASTERS DEGREE / DOCTORAL PROGRAMES IN CHINA FOR THE YEAR 2021-24


The undersigned is directed to state that Government of People's Republic of China has offered ten Master Degree Programs in different disciplines and a doctoral program for the year 2021-2024 for Government of Pakistan officials (**List attached**). The same will not involve any expenditure (TA/DA) on the part of Government of Pakistan. The period served for study under the Scholarship will be covered under the respective policies of the parent department of the selected government servants.

2. Interested candidates (Government servants of BPS-17 and above) are advised to visit EAD's website i.e. www.ead.gov.pk for Programme details, application material, general eligibility criteria and other requirements of the respective universities. Such information can be viewed in the Brochures available on the afore-mentioned website. Moreover, the candidates, who are nominated by their parent department, shall apply directly at university website and scholarship website without waiting for the final recommendation by EAD within the deadline mentioned against each discipline / program. A hardcopy of the application and documents shall be shared by the nominee with Embassy of People's Republic of China in Pakistan (Addressed to Ms. WunLinglin, Third Secretary Economic and Commercial Office) within the deadline given in Brochures.

Documents Required by EAD

In addition, the following documents (**02 sets of each**) are required to be sent along with the nomination to this Division:

- Application Form
- Information Form duly filled in by the nominee.
- FTC Proforma.
- Two copies of valid Ordinary passport.
- Copy of CNIC.
- Medical Certificate (Foreigner Physical Examination Form)
- Surety Bond
- Undertaking

3. Nominations of suitable candidates fulfilling the eligibility criteria duly approved by the competent authority may be forwarded to this Division by **14th March, 2021 positively**. All Ministries / Divisions / Attached Departments and Provincial P & D Departments must note the following points while nominating the candidates:

- a. Most relevant candidates should be nominated for Scholarship programmes.
- b. Nomination of candidates should reach EAD before the deadline. Late arrival of nomination after the EADs' deadline will not be entertained.
- c. Nomination papers complete in all respect may be forwarded to EAD through proper channel i.e. through their respective Administrative Ministry / Division/ P&D Department.
