Legislative-affairs and public officials from policy-making bodies, research institutes, and other criminal justice organizations in charge of anti-corruption measures are also acceptable on the condition that they have sufficient knowledge of the criminal justice system.
- Be university graduates or the equivalent thereof;
- Have at least 05 years of practical experience related to the main theme of this program.
- Have command of spoken and written English
- Have basic computer skills.
- Be under (50) years of age.
- Must be in good health.
