- Nominated by their respective Governments.
- Proficient in written and spoken English, and in good health.

**Objective**

This course will cover the fundamentals of conceptualizing and implementing Public-Private Partnership (PPP) projects, with a focus on Singapore's experience and context. Participants will also have the opportunity to take the APMG PPP Foundation level examination and be awarded the APMG Foundation Level Certificate.
