- Able to attend all the synchronous e-learning sessions. Participants will require an internet-enabled device with a functioning webcam, microphone and audio.
- Nominated by their respective Governments.
- Proficient in written and spoken English, and good health.

Objective

This course will cover the response to the pandemic, including insights from Singapore's experience.


