

Subject: **INVITATION/ADVERTISEMENT FOR ADMISSION UNDER PAKISTAN TECHNICAL ASSISTANCE PROGRAM (PTAP) SESSION 2025-26**

“ADMISSION NOTICE FOR THE ACADEMIC SESSION 2025-26”

Under the Pakistan Technical Assistance Programme (PTAP), administered by the Ministry of Economic Affairs (MoEA), Government of Pakistan (since 1976), a limited number of seats are available in the fields of Medicine (MBBS), Dentistry (BDS), Pharmacy (Doctor of Pharmacy), and BSc. Engineering for the Session 2025-26 for students of Pakistan Origin having **foreign nationality**.

2. All applicants who fulfill the following conditions are eligible to apply:

a) Educational Qualification

MBBS & BDS	Chemistry, Biology	<ol style="list-style-type: none">At least 60% marks in Higher Secondary School Certificate (HSSC) or its equivalent after conversion from Inter Boards Coordination Commission (IBCC)Candidates are required to have passed Medical and Dental College Admission Test (MDCAT)/University Clinical Aptitude Test (UCAT) examination, as per condition laid down by Pakistan Medical and Dental Council (PMDC)
BSc. Engineering	English, Physics, Chemistry & Mathematics.	<ul style="list-style-type: none">At least 60% marks in HSSC or equivalent from Inter Boards Coordination Commission.
D. Pharmacy	English, Physics, Chemistry & Biology.	<ul style="list-style-type: none">At least 60% marks in HSSC or equivalent from Inter Boards Coordination Commission.

**Any changes notified by the Pakistan Medical and Dental Council (PM&DC), Pakistan Engineering Council (PEC), or Pakistan Pharmacy Council will be applicable.*

b) General Conditions:

- Must have a valid proof of foreign nationality (self and parent) i.e. copy of passport.
 - Must have a valid proof of Pakistan Origin identity in form of Pakistan Origin card/ NADRA I.D. Card or Pakistani Passport.
 - Must have studied and passed 12th grade or equivalent exam physically from abroad.
3. The updated application form can be downloaded from EAD's website (www.ead.gov.pk). It should preferably be typed, printed, and submitted in quadruplicate along with attested copies of the following documents:
- HSSC or equivalent certificate along with detailed marks certificate/transcripts.
 - Equivalence certificate issued by Inter Boards Coordination Commission, in case of foreign qualification.
 - Proof of Foreign Nationality, Self and Parent (foreign passport). Green card is not accepted as proof of foreign nationality.
 - Proof of Pak-Origin (Pakistani Passport, I.D. Card etc.)
 - Result Card MDCAT/UCAT.
4. Candidates interested to apply against the above seats must submit their complete applications on the prescribed application form (in quadruplicate) in R&I/PTAP Section of Ministry of Economic Affairs along with attachments listed above, not later than **15th October, 2025 (Wednesday)** for admission in MBBS/BDS, however, for the admission in D. Pharmacy/BSc. Engineering the deadline is **15th August, 2025 (Friday)**. Applications received after the cutoff dates will not be entertained.
