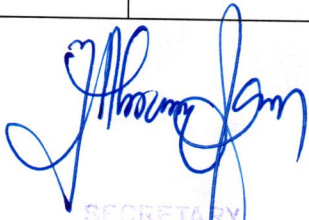

**Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 30<sup>th</sup> May, 2025**

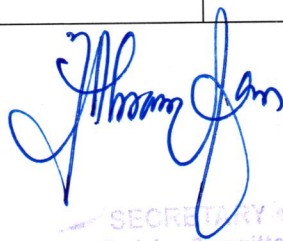

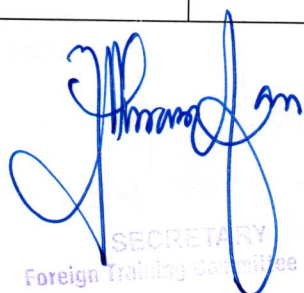

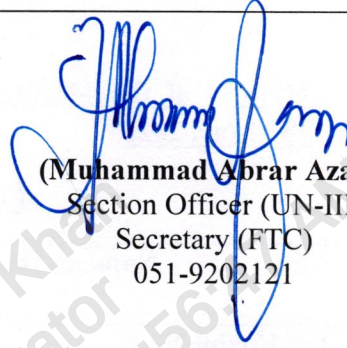
