

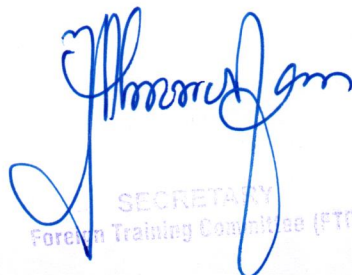

Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 13th May, 2025

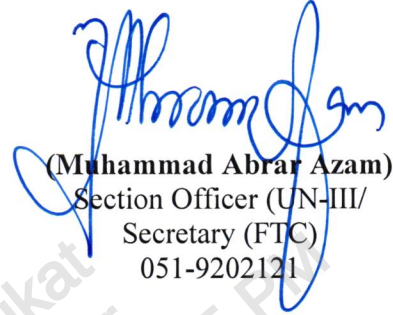
