

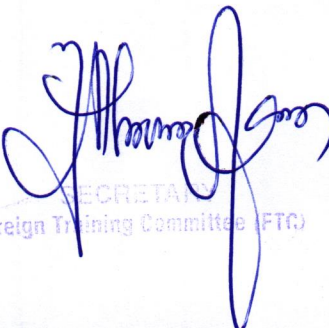

Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 12th March, 2025

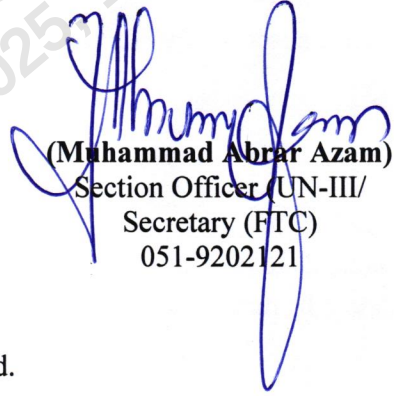

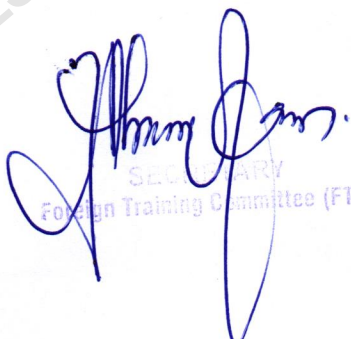
