Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 17th April, 2025

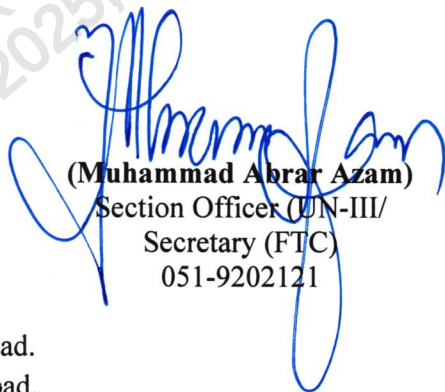

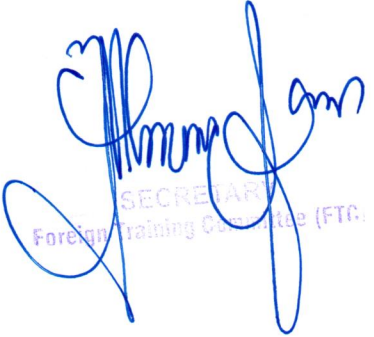
