**Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 19<sup>th</sup> March, 2025**

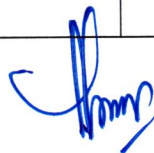

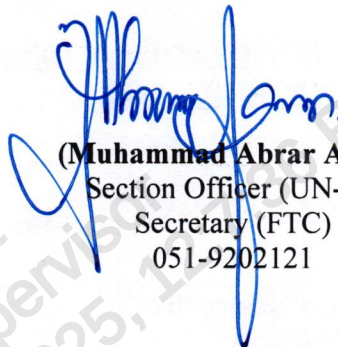
