Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 07th March, 2025

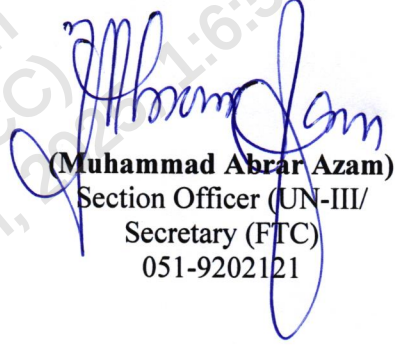

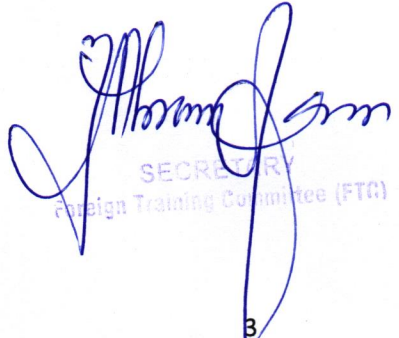
