Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 25th February, 2025

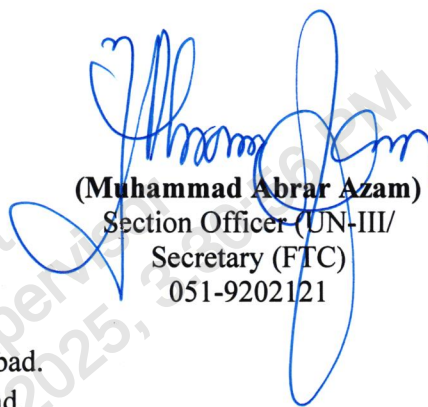
