Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 07th September, 2026

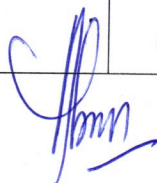

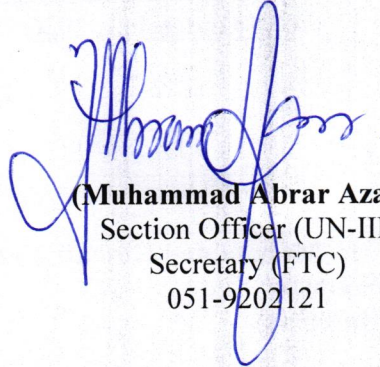
