

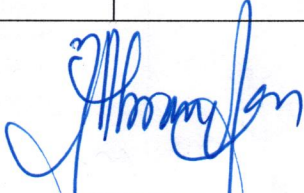

Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 13th August, 2026

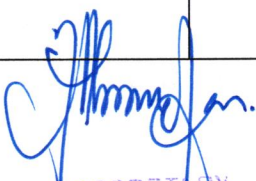

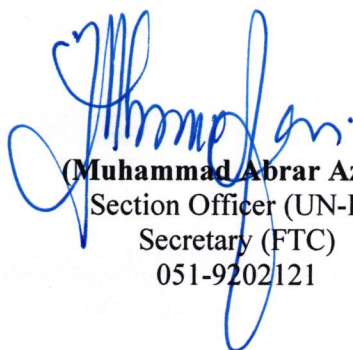
