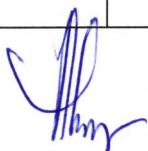
Subject: Minutes of the Meeting of Foreign Training Committee (FTC) held on 03rd August, 2026

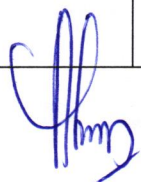

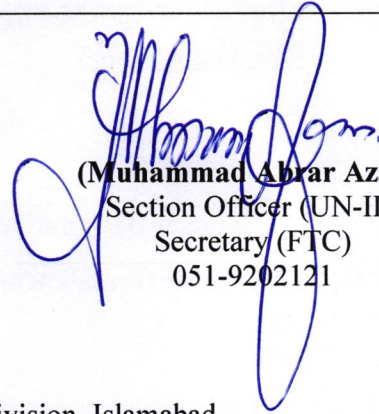
