Eligibility Criteria

- Mid to senior-level government officers (BS-17 and above) who are involved in cybersecurity policy planning and enforcement, nominated by respective Federal/Provincial Department.
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with Zoom installed, and functioning webcam, microphone and audio.
- Proficient in written and spoken English, and
- In good health

Objective

- The pervasiveness of the Internet-of-Things (IoT) and internet connectivity has brought about an unprecedented level of convenience to our lives. This growing dependence has also led to new vulnerabilities which can be easily exploited by malicious actors. This course shares Singapore's experience in adopting best practices in cybersecurity.
