## **OFFICE MEMORANDUM**

**SUBJECT: TRAINING COURSE ON INNOVATIONS IN GOVERNANCE TO BE CONDUCTED IN DOHA QATAR FROM 29 NOVEMBER 2026 TO 3 DECEMBER 2026 UNDER THE SINGAPORE QATAR ASIA MIDDLE EAST DIALOGUE AMED TRAINING PROGRAMME**

The undersigned is directed to inform that the Government of Singapore has invited nominations for the above **Partially Funded** training course. The Governments of Singapore and Qatar will bear the participants' round-trip economy class airfare and course fees, including trainers' fees, course materials and training venue. **However, the cost of accommodation, and other local and incidental costs for the participants would be borne by the nominating agency/nominee himself/herself and as insurance will not be provided, participants are strongly advised to purchase comprehensive travel insurance which includes medical evacuation in the event of any unexpected emergencies.** The [brochure](#) of the subject training course is available at [www.ead.gov.pk](http://www.ead.gov.pk).

2.The eligibility criteria and objectives of the subject course are as under:

### **Eligibility Criteria: -**

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials involved in leading and overseeing public sector reforms;
- Proficient in written and spoken English; and
- In good health.
- Prepared to participate actively in the programme.

### **Objective:-**

- This course will share Singapore's experience in public policy and service delivery innovation, as well as the capabilities the public service needs to stay relevant.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by **September 21, 2026** positively. Interested officers are requested to apply online at <https://go.gov.sg/sgqatariig2026> as required by Singapore (Mandatory). **Nomination without online application will not be considered by the host.**
