2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- The Course is designed for Air Traffic Control Officer (ATCO) or other Air Traffic Management (ATM) personnel with experience in supervisory/managerial level and rostering duty. Participants should be nominated by the respective governments based on the following:
- Passes a Good command of both written and spoken English (ICAO Level 4 minimum).
- Aged preferably 26-50 years.
- Have not participated in any MTCP previously.
- Having appropriate gadget (Laptop/desktop) with strong and stable internet connectivity of minimum 3G internet speed.

Objective:-

- Participants will understand that fatigue is a safety concern and with the essential Knowledge, skills and attitude. This risk can be managed within a safety system air traffic operation.
