Eligibility Criteria

- Government Officers (BS-17 and above) only and nominated by respective Federal Government or Provincial Department having minimum of 2 years of experience
- Have an educational background in the field of life science
- Hold a position as a technician, engineer, scientist, or manager with up to 6 years of experience in biomanufacturing or a related field.
- Be employed by a company registered as a legal entity in Low and Middle Income Countries (LMIC) conducting activities in the scope of biomanufacturing.
- Be resident in a LMIC
- Have at least an intermediate level of spoken and written English language.


Objectives

- The Global Training Hub for Biomanufacturing is mandated to provide in manufacturing of high quality vaccines and biologics in an industrial setting to resolve inequality in access to vaccines and biologics worldwide by expanding manufacturing capacity in LMICs.
