- Be relatively inexperienced technical officers engaged in sewerage works in federal / provincial governments,
 - Have more than 3 years' working experiences in sewerage works and / or stormwater drainage technology.
 - Be a graduate of university or equivalent
 - Have command of spoken and written English
 - Be preferably under 49 years of age.
 - Must be in good health.
