- Be Director level or equivalent positions who are currently in charge of Drug Law Enforcement at the Central Government.
- Be university graduates or the equivalent.
- Have at least 03 years professional experience in Drug Law Enforcement.
- Have command of spoken and written English
- Have basic computer skills.
- Must be in good health.
