Course Objective:

Participants will improve the policy -making and implementation capabilities necessary to promote renewable energy in each country.

Eligibility Criteria: -

The applicant should:

- Be in charge of Energy policy introduction, promotion, maintenance and management of Photovoltaic (PV) generation.
- Must have a good command of PV generation engineering in general.
- Have more than 2 years of working experience & engagement in the field of photovoltaic generation systems
- Have a background of Engineering.
- Have command of spoken and written English
- Be Between the age of 30 and 50 years
- Must be in good health. Pregnant applicants are not recommended to apply due to the potential risk of health and life issues of mother and fetus.
- Applicants who will make any false declaration in Medical History of Application will be terminated from the training program.
