- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with Zoom installed, a functioning webcam and audio.
- Nominated by their respective Governments.
- Proficient in written and spoken English, and
- In good health.

Objective: -

- It aims to introduce the knowledge and skills in applied epidemiology and rapid response to the participants.
- Participants will learn about outbreak detection, investigation and response activities and methodologies through a combination of seminar, lecture, case studies and panel discussions.
