Eligibility Criteria:-

The applicants should:-

- Have more than 5 years of relevant working experience.
- Be a personnel working at target organization.
- Have practical experience in DRR field.
- Be a graduate.
- Be proficient in spoken and written English
- Be in good health, both physically and mentally.
- Be of 35 years or younger for Master's degree and 40 years old for doctoral degree.
