Eligibility Criteria:-


The applicants should be:-

- A member of government organization in charge of water related disaster risk reduction, flood control, sediment control, or watershed management.
- Have a working experience of over five (5) years in the field of water related disaster risk reduction, flood control or watershed management
- A graduate or equivalent
- Proficient in spoken and written English
- Able to operate computer
- Between the age of twenty-eight (28) and forty (40) years
- In good health, both physically and mentally, to participate in the program in Japan.
- Pregnant applicants are not recommended to apply due to the potential risk of health
