- Be responsible for planning / designing maternal projects for newborn and child health (MNCH)
  - Have at least 3 years working experience in planning, administration, implementation and monitoring / evaluation in the field of MNCH and / or reproductive health.
  - Proficient in spoken and written English
  - Be between the age of thirty (30) and fifty (50) years
  - Be in good health, both physically and mentally.
