Course Objective:

Eligibility Criteria:-

The applicant should:

- Be senior officers of the planning department of a railway company with an urban railway line, such as commuter rail, underground railway, LRT (Light Rail Transit) and MRT (Mass Rapid Transit) or its equivalent.
- Have more than 5 years' working experiences in the field of railway business.
- Be a graduate of university or equivalent
- Have command of spoken and written English
- Have basic computer skills such as sending / receiving email with attachments and using a web browser.
- Be the age of 45 years or younger in principle.
- Must be in good health.
