- Bachelor Degree or an equivalent to college/ University level Educational background for Master Degree Programmes.
- Master Degree or an equivalent to college/ University level Educational background for Doctoral Degree Programmes.
- English Language Proficiency proof/ English Language Test score as per attached course document.
- Not be a person who has withdrawn from KOICA's scholarship program.
- Have not participated in any of the Korean Government's Scholarship Program before.
