2. The eligibility criteria and objectives of the subject course are as under:

**Eligibility Criteria**

- Be a Government Officers (BS-17 and above) or researcher in institutes in the agricultural field nominated by respective Federal Government or Provincial Department
- Be nominated by his/her government;
- Be in good health both physically and mentally to take the course;
- Have a willingness to show a high level of participation and commitment throughout the course and contribute to the capacity building of his/her organization after the completion of the program;
- Have not participated in the same or similar KOICA Fellowship Program in the past three years, unless otherwise specified; (however, a key person for the course of an intensive performance management program, for example, may participate in the same or similar KOICA Fellowship Program, subject to pre-discussion with KOICA)
- (IT literacy) Have working knowledge of computers and related digital technology and perform basic tasks such as operating software systems, online platforms and other communication programs (Windows, MS Office, Google, Zoom, email, etc.);
- (Original place of employment) Works at the Pakistan Council of Renewable Energy Technologies (PCRET)
- (Position) Be a government employee in a working-level position in the renewable energy related sector (an engineer, technician, etc.)
- (Relevant work experience) Have more than 5 years of experience;
- (Language capability) Have sufficient proficiency in written and spoken English to actively participate in seminars and write an Action Plan PREFERABLE
- Any other preferable qualifications
- Be able to contribute to cooperation between related organizations
- 3 or more female participants
- (ICT Literacy) Have easy access to internet and equipped with working knowledge of computers

- To analyze the current status of renewable energy in Pakistan and come up with applicable solutions for Pakistan;
- To learn recent appropriate technologies in the renewable energy field;
- To establish renewable energy policies based on Pakistan's situation;
- To learn advanced know-how on renewable energy policy, infrastructure construction, operation and management;
- To achieve applicable concepts & schemes on advanced renewable energy policy & system and environmental regime;
- To strengthen future cooperation and enhance mutual understanding between Pakistan and the Republic of Korea.
