Eligibility Criteria

- Be Government Officers (BS-17 and above) only and nominated by the Federal Government
- 26-45 years old;
- At least a Bachelor degree holder in IT;
- At having a 2 years relevant experience (e.g., System administrator, network engineer, SOC analyst);
- Should have a fundamental understanding on information security/security assessment;
- Proficient in the English language; and
- Medically fit.

Objective

- To provide a general understanding about the essential components of digital security, importance of cybersecurity, and create awareness on the growing cyber threats and trends.
- To learn how to prevent general attacks, conduct assessments, and harden the common types of network and systems towards digital security ecosystem.
- To enable participants to Implement data protection policies, regulatory requirements, latest data security technologies and audit database activities.
- To enable the participants to understand the overall concept of the certification.
- To develop participants practical skills and knowledge to conduct audits and improve the implementation of information management system in accordance with the to Iso/IEC 27001:2013.
- To equip the participants with the knowledge and skill to plan, implement, and manage their respective country chapters while anticipating the potential development and operational challenges whilst ensuring sustainability.


