- Proficient in English language, and medically fit.

Objective

- Cultivating awareness, nurturing adopting and establishing capabilities in securing information effectively and creating a safer cyberspace.
- Providing practical knowledge in analysing and managing system vulnerabilities.
- Providing practical experience in managing security incidents and defending security perimeters.
- Building capable cyber security professionals for the region.
- To understand different attacks used by hackers.
- To learn how to conduct vulnerability assessment on the network and system.
- To learn ways to harden the network and systems thus securing the corporate network and systems.
- To prepare and submit vulnerability Assessment and Pentest Reports.


