**OFFICE MEMORANDUM**

Subject: **TRAINING COURSE ON "DYNAMICS OF YOUTH AND TERRORISM: UNDERSTANDING AND COUNTERING THE ISSUE" TO BE HELD FROM 4-12 AUGUST 2020 AT KUALA LUMPUR, MALAYSIA**

The undersigned is directed to inform that the Government of Malaysia through Medical Relief Society Malaysia in Southeast Asia Regional Centre for Counter-Terrorism (SEARCCT) will be organizing the **Fully Funded** subject training programme and has invited **two (02)** nominations for the said programme. 2. The objectives and eligibility criteria of the course are as under:

**Objectives:**

- To provide participants with the knowledge and understanding of the psychological make-up and behavioral patterns of youths that are susceptible to terrorism;
- To create awareness among participating countries on the dynamics of youth and terrorism;
- To provide the participants with an avenue to exchange views, experience and possible solutions on how best to address the issue and
- To provide the participants with the necessary knowledge to recommend to their respective governments on how to deal with the involvement of youth in terrorism.

**Eligibility Criteria:**

To be eligible to apply, applicants of the course are obliged to fulfil the following requirements:


- Permanent Government Officers (BS-17 and above) nominated by respective Federal/ Provincial Government
- Must be between the ages of 26 – 46 years at the commencement of the course;
- Must possess a university degree; Fluency in both spoken and written English;
- Medically fit (applicants must submit his/her medical report together with the application form).

3. Nomination of suitable candidates fulfilling the laid-down eligibility criteria prescribed by the sponsoring agency duly approved by the competent authority alongwith following documents may be forwarded to this Division by **4<sup>th</sup> May, 2020 (Monday)** positively.
