- Online Training Link will be sent out via Email to successful candidates.

- Deepen and broaden the understanding of the causes and effects of corruption and negative consequences on the well-being of the nation and citizen.
- Strengthen their technical know-how and skills in corruption prevention, detection, investigation, prosecution, and community education.
- Develop and effective anti-corruption strategic plan drawing lessons from best(and worst) practices in the region.
