- To encourage continuous networking between participants and the IMR in future research projects and educational purposes


Eligibility Criteria:

- Government Officers (BS-17 and above) nominated by respective Federal Government or Provincial Department
- Entomologist/ Scientific Officer intending to work in acarology research
- Between 26-50 years of age.
- Should have practical experience of more than three (3) years in relevant field.
- Should possess a good command of written and spoken English.
- Good health, physically and mentally, in order to complete the course.
- Have not participated in any training programme under MTCP.

3. Nomination of suitable candidates fulfilling the laid-down eligibility criteria prescribed by the sponsoring agency duly approved by the competent authority alongwith following documents may be forwarded to this Division by **1st May, 2020 (Friday)** positively.
