OFFICE MEMORANDUM

SUBJECT: TRAINING COURSE ON INCLUSIVITY IN MULTICULTURAL SOCIETIES, TO BE CONDUCTED IN-PERSON IN SINGAPORE FROM 15 TO 19 FEBRUARY 2027 UNDER THE SINGAPORE COOPERATION PROGRAMME TRAINING AWARD SCPTA

The undersigned is directed to inform that the Government of Singapore has invited nominations for the above **Partially Funded** training course. The Government of Singapore will bear local hospitality (accommodation and local transfers), course fees, training allowance and group personal accident/hospitalization insurance. **The cost of round-trip airfare for the participants would be borne by the nominee himself/herself.** The brochure of the subject training course is available at www.ead.gov.pk.

2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria: -

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials who are involved in policymaking for social development, community planning and management;
- Proficient in written and spoken English; and
- In good health.

Objective: -

- The course will focus on race, religion and intergroup relations to help participants understand the complexities of managing diversity in contemporary societies. It will provide insights on how unconscious biases and group dynamics shape social cohesion, explore approaches to advancing gender and ethnic inclusion, and develop practical leadership skills for fostering inclusivity.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by **December 01, 2026** positively. Interested officers are requested to apply online at <https://go.gov.sg/scptaims2027> as required by Singapore (Mandatory). **Nomination without online application will not be considered by the host.**

Further, it may be apprised that as per direction of Foreign Training Committee (FTC) of Ministry of Economic Affairs, all officers proceeding on foreign trainings have been directed to submit a 1000-word post-visit report upon return. Accordingly, the officers who are nominated may submit a post visit report to Section Officer (SEA) upon return.
