2. The eligibility criteria and objectives of the subject course are as under:

**Eligibility Criteria**

- Government employees (BS-17 and above) having minimum 10 years working experience and nominated by the respective Federal Ministry or Provincial Department.
- Mid to Senior level government officials who are involved in infrastructure projects planning and management.
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with Zoom installed, webcam, microphone and audio.
- Proficient in spoken and written English.

**Objectives**

- This course will cover the fundamentals of conceptualizing and implementing Public-Private Partnership (PPP) Projects, with a focus on Singapore experience and context. Participants will also have the opportunity to take the APMG PPP Foundation level examination and be awarded the APMG Foundation Level Certificate.


