- Mid to Senior level government officials involved in Public Health / National emergency planning and management.
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with Zoom installed, webcam, microphone and audio.
- Proficient in spoken and written English.

- The COVID-19 pandemic has rapidly evolved in to an unprecedented and multi-faceted crises. Governments have had to grapple with a public health crises. They have had to deal with its complex socioeconomic impact while maintaining public trust, support and complains with various measures.
- The programme will share Singapore's WHOLE -OF Government and multi-sectoral approach to pandemic management drawing lessons from management the COVID-19 pandemic.


