2 The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria

- Mid to senior-level government officers (BS-17 and above) who are currently working on issues related to the Law of the Sea, nominated by respective Federal/Provincial Department.
- Able to attend all the synchronous-learning sessions. They will require an internet-enabled device with Zoom installed, and functioning webcam and audio.
- Proficient in written and spoken English, and
- In good health

Objective

- This course aims to provide participants with a summary of climate change's impacts on the oceans, as well as how the Law of the Sea (as reflected in United Nations Convention on the Law of the Sea (UNCLOS) can be used to address them. The limits of UNCLOS in addressing these impacts will also be discussed.
