- This course aims to provide participants with a summary of climate change's impacts on the oceans, as well as how the Law of the Sea (as reflected in United Nations Convention on the Law of the Sea (UNCLOS) can be used to address them. The limits of UNCLOS in addressing these impacts will also be discussed.
